IMPORTANT NOTICE

Registrations are automatically suspended, retroactive to January 1st if not renewed by February 28th. If you practice without a current registration with this Board you will be in violation of NRS 625A and NAC 625A. Expired / suspended registrations may be reinstated but **will not be retroactive**. A Reinstatement Application and payment of **\$200.00** will be required.

NRS 625A.900 Unlawful to practice without certificate; penalties.

1. On and after July 1, 2007, a person shall not engage in the practice of environmental health in this State unless the person holds a certificate of registration as an environmental health specialist or an environmental health specialist trainee issued by the Board pursuant to this chapter.
2. Any person who violates any provision of this section is guilty of a misdemeanor.

NAC 625A.017 Certificate of registration: Date when application for renewal and annual fee are due; effect of noncompliance. ([NRS 625A.080](#), [625A.130](#))

1. An application for renewal of a certificate of registration and the annual fee required pursuant to [NRS 625A.130](#) must be received by the Board not later than 60 days after the end of each calendar year.
2. The certificate of registration of an environmental health specialist or environmental health specialist trainee is automatically suspended if the specialist or trainee fails to submit an application for renewal of the certificate and the annual fee required pursuant to [NRS 625A.130](#) within the period prescribed in subsection 1.

All Sections of the Application are mandatory and must be completed. Incomplete applications will be assessed a \$50.00 processing fee and will be returned for completion. Attach a copy of proof of completion of continuing education for the previous 2 years immediately preceding the date of your Reinstatement Application documenting completion of **24 hours of continuing education**.
